ABOUT THE PROGRAMME

RIS has been conducting capacity building programmes, under the ITEC Programme of the Ministry of External Affairs, Government of India, for the participants from ITEC Member countries. These programs are on, inter alia, global trade and economic issues, and South-South Cooperation. In January 2017, RIS initiated a Programme on Science Diplomacy. Thirty participants from twenty-five countries participated in this. The Programme covered many themes, including, various aspects of Science Diplomacy, trends in global science and technology and the growing role of South-South Co-operation in science and technology.

In 2018, RIS will conduct the Programme on Science Diplomacy from 8th to 19th January. The prospective participants in the course will be from civil service, diplomacy and others in such as academia, research, and media, and/or, engaged in science and technology related themes in foreign affairs and/or managing international research projects in science and technology.

PROGRAMME CONTENTS AND THEMES

The course will enable the participants to understand the role of Science Diplomacy in foreign policy and strategy, trends in science and technology and international affairs, and, science and technology and regional and South-South Cooperation.

The course includes lectures, case studies, self study, group discussions and field visits. Back ground material and resource support for learning will be provided to all participants by RIS. As English is the working language for this programme it is expected that the participants will be able to understand, and communicate in English.

The following themes will be covered in the Program.

- **Science and Technology and International Affairs**
 - **Modalities of Science Diplomacy at Bilateral, Regional and Multilateral Levels**
 - **Science, Technology and Innovation (STI) and Developmental Challenges and Role of Science Diplomacy**
 - **Trade, Investment and Technology**
 - **South-South Cooperation and Science Diplomacy**

FACULTY

The Faculty will be from inter alia, RIS, Jawaharlal Nehru University (JNU), South Asian University, TERI, UN agencies such as UNESCO and UNDP, and international organizations like CABI. Besides these, experts in science diplomacy, diplomats/officials with experience in multilateral negotiations related to science and technology, and expert/policy makers/ regulators from various departments/agencies of Government of India will be associated with this Programme.

The Faculty from RIS will include, Prof. Sachin Chaturvedi, Prof. S.K. Mohanty, Prof. T.C.James, Dr. T. P. Rajendran, Dr. K. Ravi Srinivas, Dr. Sabyasachi Saha and Dr.Amit Kumar.

DURATION

The Course would be held from **8 January 2018** to **19 January 2018**. Participants are expected to arrive in New Delhi by **7 January 2018**.

ELIGIBILITY

- The participants should be Graduates or have a higher qualification with a working knowledge of English.
- The course is open to government officials, diplomats, academicians, researchers and journalists from the developing and transition economies, dealing with international economic and developmental policy issues and/or science, technology and innovation issues, particularly science counselors or attaches dealing with science and technology.
- Applicants should be working in and citizens of the ITEC Member countries. Experience with diplomatic assignments related to science and technology/ Experience with South-South Cooperation (SSC)/North-South Cooperation (NSC) is desirable and this is not an essential qualification for prospective participants.

ALLOWANCES

The Programme covers return travel of the participants between his/her home country India, accommodation, living allowance, book allowance etc., as per the rules governing ITEC/SCAAP Programme of the Ministry of External Affairs, Government of India.
